

Cancellation Notice – Golden Ticket Raffle

St. Stephen's Marthoma Church is sorry to announce that due to limited interest in the fund raising raffle event, the Golden Ticket (NJ LGCCID:114-1-38756); the raffle that had a scheduled drawing on the 15th of September 2018 has been cancelled.

All monies raised through raffle ticket sales will be fully refunded. Alternatively, ticket holders may mail their ticket stubs, along with their name and contact information, to the St. Stephen's Marthoma Church office at 423 Dunhams Corner Road, East Brunswick, NJ 08816 prior to October 30 2018 for a full refund of the ticket purchase price.

St. Stephens Marthoma Church will also attempt to contact each ticket holder based on the contact information on file to initiate refund procedures of the ticket purchase price within 30 days from the time of posting this notice.

Refunds will be issued based on payment method – by check if original payment was made by check or by credit card used for payment if original payment was made by credit card.
